The Firm is the investment manager to Melvin Master, a Cayman Islands exempted company, Melvin Capital Onshore LP, a Delaware limited partnership ("Melvin Onshore"), Melvin Capital II LTD, ("Melvin II") and one or more managed accounts (the "Managed Accounts" and together with Melvin Master, Melvin Onshore and Melvin II, the "Melvin Funds and Accounts").

As of February 20, 2019, the Firm may be deemed to beneficially own an aggregate of 8,541,440 shares of Common Stock of the Issuer. The number of shares reported above consists of (i) 4,146,655 shares of Common Stock held by Melvin Master, (ii) 776,531 shares of Common Stock held by Melvin Onshore, (iii) 1,917,401 shares of Common Stock held by Melvin II, and (iv) 1,700,853 shares of Common Stock held by the Managed Accounts. The Firm, as the investment manager to the Melvin Funds and Accounts, may be deemed to beneficially own the 8,541,440 shares of Common Stock held by the Melvin Funds and Accounts. Ownership is based on 161,063,557 shares of Common Stock deemed issued and outstanding as of February 20, 2019 based on information from the Issuer.
